

**2010 Germany Wine Trip Giveaway**  
**OFFICIAL RULES**

**1. NO PURCHASE, PAYMENT, OR DONATION IS NECESSARY TO ENTER OR TO WIN. A PURCHASE, PAYMENT, OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING. ONLY ONE ENTRY PER PERSON. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

2. The 2010 Germany Wine Trip Drawing (the “Drawing”) is open only to persons 21 years of age or older at the time of entry and who are lawful residents of the 50 United States and the District of Columbia. Void in Puerto Rico and where prohibited or otherwise restricted by law. The officials, officers, and employees of the Town of Addison, Texas, its advertising and promotional agencies, participating Addison Oktoberfest sponsors, and of all contractors involved with the Addison Oktoberfest event, and the immediate family members of, and any persons domiciled with, any such officials, officers, and/or employees, are not eligible to enter or to win. The term “immediate family members” includes spouses, parents, grandparents, siblings, children, and grandchildren.

To enter the Drawing: (a) obtain an official drawing entry form at any DFW Albertsons from August 18 – September 19, 2010 and mail completed entry form to Town of Addison Special Events Dept, Attn: Germany Wine Trip Entry Form, PO Box 9010, Addison, TX 75001; (b) mail a request for an official Drawing entry form to Town of Addison Special Events Dept, Attn: Germany Wine Trip Entry Form, PO Box 9010, Addison, TX 75001 (include with your request a self-addressed, stamped envelope for return of the entry form to you), once received complete the same, and return it by mail to the same address; (c) obtain an official Drawing entry form at the Oktoberfest 2010 event (to be held from Thursday, September 16, 2010 through Sunday, September 19, 2010 (admission on Thursday, September 16, 2010 is free!), complete it, and deposit it at the Blufeld Lounge; No purchase, payment, or donation is necessary or required to enter the Drawing. Only one entry per person is allowed. The odds of winning are the same no matter the method of entry selected. Odds of winning will be determined by the number of eligible, valid entries received, and therefore the odds of winning cannot be determined in advance of the Drawing because the total number of eligible, valid entries will not be known until the time of the Drawing. 7. One (1) winner of the Prize will be selected in a random drawing from among all eligible entries received to be held on or about 10:00 a.m. on September 27, 2010. A winner need not be present to win.

9. Subject to verification of eligibility and compliance with these Official Rules, the winner will receive the designated Prize for which the winner's name was drawn.

10. Official photo identification (e.g., valid driver's license) will be required to claim the Prize. Winner will be notified by telephone and email provided by Winner at time of entry. If the Town of Addison is unable to reach winner within five (5) business days following the date of the Prize drawing, he or she will be disqualified and will forfeit all interest in the Prize, and a substitute winner will be selected. In the event that more than one entry is accidentally drawn from the hopper, there will be a random drawing from among the entries that have been simultaneously drawn to determine a winner.

In the event the winner does not accept the Prize for any reason, is deemed ineligible by the Town of Addison, or fails to comply with these Official Rules, the Prize will be awarded to a substitute winner selected in a random drawing from among all remaining eligible entries. This process will be repeated if necessary until a winner is determined.
